POLICY BULLETIN NO. 60

SUBJECT: Application for Membership and Electric Service

POLICY:

In accordance with Article I, Section 1, of the Bylaws, all persons interested in securing electric service from the Cooperative must make application for membership on the approved standard application form attached hereto and made a part hereof.

RESPONSIBILITY:

Board of Directors and all employees.

PROCEDURE:

1. Application – The Cooperative will require each prospective Member to sign an “Application for Membership and Electrical Service in Clearwater Power Company” (Application) and agree to abide by the provisions of the Articles of Incorporation, Bylaws, Policies, procedures, rules, regulations and rate schedules as may from time to time be adopted by the Cooperative.

In the absence of a signed Application, the delivery of electrical service by the Cooperative, and its use by the consumer, shall be deemed to constitute an agreement to abide by the provisions of the Articles of Incorporation, Bylaws, Policies, procedures, rules, regulations and rate schedules of the Cooperative.

2. Right to Reject – The Cooperative reserves the right to reject any application for service not available under its rate schedules or line extension policy, or which involves excessive costs, or which might affect the supply of service to others, or for other good and sufficient reasons.

Service will not be furnished to former Members until any indebtedness to the Cooperative has been paid in full, unless required by law.

3. Special Contracts – Additional contracts may be executed on the adopted form(s) in accordance with Member Contracts (Policy Bulletin No. 68) to safeguard the Cooperative’s investment.

4. Additional Connections – A Member may have as many additional connections as desired or needed subject to the provisions of the Articles of Incorporation, Bylaws, Policies, procedures, rules, regulations and rate schedules of the Cooperative.

5. Estates – A deceased Member’s account may remain open; however, the person, firm, corporation, or body politic responsible for the decedent’s account will continue to be billed for debts incurred under the account of the deceased Member, and for charges incurred on the account until such time as the estate is closed. At that time all amounts shall become due and payable, and the person, firm, corporation, or body politic responsible shall apply for Membership and electric service as outlined in the foregoing paragraphs.

6. Acceptance – An application or contract, when accepted by an officer or authorized agent of the Cooperative, shall constitute a part of the contract between the Member and the Cooperative and no agent has the power to modify, alter, or waive any of its conditions without the consent of the Board of Directors and the Member.

**APPLICATION FOR MEMBERSHIP AND ELECTRIC SERVICE
IN
CLEARWATER POWER COMPANY**

The undersigned (hereinafter called the "Applicant") hereby applies for membership in and agrees to purchase electric energy and capacity from CLEARWATER POWER COMPANY (hereinafter called the "Cooperative"), upon the following terms and conditions:

1. The Applicant will pay for electric service rendered at monthly rates in accordance with the rate schedules adopted from time to time by the Cooperative. The Cooperative may limit the amount of electric energy and capacity to be furnished to the Applicant.

2. The Applicant, by becoming a member, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that under the law their private property cannot be attached for any such debts or liabilities.

3. The Applicant will comply with and be bound by the provisions of the Articles of Incorporation and Bylaws of the Cooperative, and such rules, policies, regulations and rate schedules as may from time to time be adopted by the Cooperative. Applicant acknowledges that a copy of the current Bylaws and Articles of Incorporation of the Cooperative are available on the Cooperative's webpage at www.clearwaterpower.com or by request.

4. The Applicant acknowledges that the Cooperative may, in accordance with policies adopted or changed from time to time by its Board of Directors, discontinue any and all electric service to Applicant in the event Applicant fails to pay any bill for electric service rendered, even if the electric service to Applicant is separately metered and billed to Applicant or if electric service is rendered to Applicant under a separate contract between the Applicant and the Cooperative. Applicant authorizes the Cooperative, in its sole discretion, to recoup, offset, or set off any amount owed to the Cooperative by the Applicant, including any compounded interest and late payment fee, by reducing the amount of any capital credits, patronage dividends, or similar amounts retired and paid to Applicant, regardless of any statute of limitations.

5. By giving your phone number to the Cooperative, the Applicant is providing express written consent to the Cooperative to contact the Applicant by phone and use an automatic telephone dialing system or an artificial or prerecorded voice to contact the Applicant for Cooperative business purposes. The Applicant agrees to notify the Cooperative of any change in the Applicant's phone number.

6. The Applicant agrees that the Cooperative's Articles of Incorporation, Bylaws, policies and procedures, and any dispute between the Applicant and the Cooperative, shall be governed by, and interpreted under, the laws of the State of Idaho.
